4. DISCUSSION/ACTION ON SPECULATIVE BUILDING.

He asked if everyone understood he was preparing an RFP primarily to get estimates on the costs to hire and architect. He said that he looked at the 2014 estimate from the contractor and saw that he used about \$93,000.00 in his estimate for architect and engineering services on a \$2.7 Million project. Executive Director Ayres reported he visited several websites and the costs seemed to very by the complexity of the building. He added that it appeared a big box warehouse building was among the least complex. He said that several

websites showed a range of 3% to 6% of the project costs, which on a \$3 M building would be \$90,000 to \$180,000. Executive Director Ayres shared that he found a template on the American Institute of Architects website that he as modified for our KEDC needs. He said he is now seeking out architects to send the RFP to. After some discussion, no action was taken.
