1. HOLD A WORKSHOP FOR THE ECONOMIC DEVELOPMENT STRATEGIC PLANNING INITIATIVE.

Mr. John Karras, TIP Strategies, stated that he had received feedback from the previous meeting, incorporated it into the Implementation Matrix, and reviewed the revised Matrix.

The ED Master Plan goals are as follows: Support the growth of existing employers; recruit new businesses and investment into the community; invest in sites and infrastructure to meet the needs of current and future employers; encourage entrepreneurship and small business growth; strengthen workforce development and educations programs; create new amenities (including downtown) for tourism and talent attraction; aggressively pursue new housing development; enhance Kaufman's Economic Development tools and resources; and aggressively pursue new housing development.

Anne Glasscock individually reviewed the various items on the Matrix and received input concerning what the respective roles of the City of Kaufman, Kaufman Economic Development Corporation, and Kaufman Chamber of Commerce would be, as well as establishing timelines for each project.

Executive Director Lee Ayres thanked the group for their participation and stated that that he would have the consultants come to the City one more time to meet with the City Council and Economic Development Corporation.
